## Regulations of the Julia Zdanowska Scholarship Fund

The Julia Zdanowska Scholarship Fund, hereinafter referred to as the "Fund", is an expression of commemoration of the young Ukrainian mathematician Julia Zdanowska (Юлії Здановської), medallist of the European Girls' Mathematical Olympiad (EGMO), mathematics graduate of the Taras Shevchenko National University of Kiev and a computer science and mathematics teacher, as part of the "Teach For Ukraine" initiative.

§ 1

The aim of the Fund is to support outstanding graduates of foreign secondary schools located in the territory of one of the Baltic countries (Lithuania, Latvia, Estonia), Eastern European countries (Belarus, Moldova, Ukraine), Transcaucasia (Armenia, Azerbaijan, Georgia) or Central Asia (Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan, Uzbekistan) who will undertake studies at the Faculty of Mathematics and Computer Science of the Jagiellonian University, hereinafter referred to as the "Faculty", by awarding them scholarships for outstanding academic results.

§ 2

The funds allocated for the payment of scholarships are recorded in a separate account called "own scholarship funds" and come from a write-off against the costs of educational and scientific activities or payments from natural and legal persons.

§ 3

A person who meets all of the following conditions may apply for a scholarship from the Fund:

- 1) he/she graduated from a secondary school located in one of the countries listed in § 1 no more than 3 years before the competition was announced or is a student of such a school at the time of the competition announcement.
- 2) he/she has outstanding academic results, in particular is a finalist of the national mathematics, IT or physics Olympiad and is active in the field of mathematical sciences.

§ 4

- 1. The amount of the scholarship is determined annually by the Dean of the Faculty, provided that the maximum monthly amount of the scholarship cannot exceed 80% of the monthly amount of the scholarship paid under the scholarship fund of the Jagiellonian University Scholarship. The scholarship is awarded for the entire period of full-time first-cycle studies at the Faculty and is paid in equal amounts for ten months a year from October to July until completion of these studies, for a maximum of 30 months.
- 2. In addition to the scholarship referred to in section 1, scholarship holders are entitled to additional benefits specified in the annex to the Fund Regulations. Additional benefits available to the scholarship holder are not charged to the Fund.
- 3. A scholarship holder who has transferred to another field of full-time first-cycle studies within the Faculty has the rights specified in section 1 and 2 for the period of study in the new field of study. Fees paid up to this point are non-refundable and will not be paid again in connection with a change of field of study.
- 4. A scholarship holder who received a scholarship for the period of full-time first-cycle studies may apply for an extension of the rights specified in section 1 and 2 for the period of full-time second-cycle studies immediately following the first-cycle studies,

for a maximum of 20 months, provided that the first-cycle studies are completed within the period provided for in the study program. The scholarship holder's application for the extension of rights is reviewed by the Committee referred to in § 5 point 2, taking into account the academic results and scientific achievements, and the final decision on the extension of rights is made by the Dean of the Faculty.

- 5. The scholarship holder is obliged to indicate for payment of the scholarship a bank account kept in Polish zlotys (PLN) in a bank operating in the Republic of Poland.
- 6. The condition for payment of the scholarship is to start studies at the Faculty in the year in which the competition was held.
- 7. The condition for admission to studies at the Faculty is for the scholarship holder to fulfil all procedures and conditions specified in the recruitment rules for studies at the Jagiellonian University.

§ 5

## Dean of the Faculty:

- 1) decides to announce the competition in a given academic year.
- 2) appoints a Commission for a two-year term to conduct the competition, composed of four Faculty employees and one representative of the Faculty students;
- 3) awards once a year, after conducting a competition, no more than 6 scholarships.

§ 6

- 1. The Information about the announcement of the competition for a scholarship under the Fund and the rules for awarding it shall be published on the Faculty's website by May 1.
- 2. Applications for participation in the competition should be submitted by June 1 via the form available on the Faculty website.
- 3. The competition participant submits via the form referred to in section 2, necessary personal data (name, surname, number and series of passport or other travel document, telephone number and e-mail address).
- 4. Processing of the above personal data by the Jagiellonian University is carried out in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95 /46/EC (General Data Protection Regulation) and the Act of May 10, 2018 on the protection of personal data (Journal of Laws of 2019, item 1781) to the extent necessary for the purposes of conducting the competition and recruitment for studies at the Jagiellonian University.
- 5. The competition participant in the form referred to in section 2, also indicates the fields of study offered at the Faculty (computer science, analytical computer science, mathematics, computer mathematics, artificial intelligence) in which he would like to undertake full-time studies, marking them with numbers from 1 to 5, where 1 means the most preferred field of study and 5 means the least preferred field of study.
- 6. To the form referred to in section 2, the following should be attached:
- 1) a cover letter containing, in particular, a C V and a description of the competition participant's most important achievements and scientific interests.
- 2) scans of documents confirming the fulfilment of the conditions referred to in § 3.

§ 7

1. When determining the results of the competition, the Commission considers the following criteria:

- 1) achievements in a national mathematics, computer science or physics Olympiad or one of the following international Olympiads: mathematics (IMO), computer science (IOI), artificial intelligence (IOAI), astronomy and astrophysics (IOAA), physics (IPhO), linguistics (IOL) or in the international competitions Romanian Master of Mathematics (RMM), Romanian Master of Informatics (RMI), International Zhautykov Olympiad (IZhO) or the European Girls' Mathematical Olympiad (EGMO) or the European Girls' Informatics Olympiad (EGOI) weight 60%, grade in scale from 0 to 10 points;
- 2) other scientific achievements and other activity in the field of mathematical sciences of the competition participant weight 40%, grade on a scale from 0 to 10 points.
- 2. When determining the results of the competition, the Commission also assesses the possibility of the competition participant to undertake studies in his most preferred fields of study. If places are unavailable in the fields of study most preferred by the competition participant, the Commission proposes other fields of study available at the Faculty.
- 3. After the competition, the Committee presents to the Dean of the Faculty no more than six candidates for the scholarship and two additional competition participants who are on the reserve list for the scholarship.
- 4. The Dean of the Faculty makes the final decision on the results of the competition. The decision specifies the field of full-time first-cycle studies for which the scholarship holder will be recruited.
- 5. Competition participants are notified about the competition results via e-mail to the e-mail address provided in the form.
- 6. The list of scholarship holders and people on the reserve list is announced on the Faculty website no later than July 1.

§ 8

- 1. If, after the competition results, the limit of the awarded scholarships has not been reached, in particular if the scholarship holder did not register for studies within the deadline set as part of a separate recruitment path in the recruitment schedule specified by the Rector of the Jagiellonian University or resigned from the scholarship in writing or electronically, the Dean of the Faculty may award a scholarship to a competition participant who is on the reserve list for a scholarship. Priority in awarding the scholarship is determined by the order on the reserve list.
- 2. The condition for awarding a scholarship to a competition participant who is on the reserve list for a scholarship is that he/she commences studies at the Faculty in the year in which the competition was held.
- 3. The scholarship will be awarded to a competition participant on the reserve list by October 5 and in the year in which the competition was held.
- 4. A supplementary list of scholarship holders is announced immediately on the Faculty website.

§ 9

- 1. The scholarship holder loses the right to receive the scholarship and exercising the rights referred to in § 4 section 2 and is obliged to return the scholarship already paid in full if circumstances are revealed that exclude the right to receive it, in particular if the conditions specified in § 3 are not met.
- 2. The scholarship holder loses the right to continue receiving the scholarship and exercising the rights referred to in § 4 section 2, from the following month in the case of:
- 1) final removal from the list of students of the field of study run by the Faculty, to which he was admitted in connection with the scholarship awarded or referred to in § 4 section 3 and 4;
- 2) withdrawal from studies

- 3) transfer to another university
- 4) suspension of student rights
- 5) completion of studies in the field for which a scholarship was awarded or referred to in § 4 section 3 and 4.
- 3. The scholarship holder may lose the right to continue receiving the scholarship and exercising the rights referred to in § 4 section 2, in case of:
- 1) failure to pass courses taken according to the individual organization of studies
- 2) repeating the year
- 3) conditional registration for the next year of studies
- 4. In the cases specified in section 3, the decision is made by the Dean of the Faculty, of which the scholarship holder is notified by sending a notification to the e-mail address in the domain @student.uj.edu.pl. An objection to the Dean's decision may be submitted, through the Committee, to the Dean of the Faculty within seven days from the date of notifying the scholarship holder of the decision. The decision of the Dean of the Faculty regarding the objection is final.
- 5. If the scholarship holder takes a leave of absence from classes, the scholarship payment is suspended until the student registers for the next year of studies. In particularly justified cases, the Dean of the Faculty may decide to pay the scholarship despite the scholarship holder taking leave from classes.

§ 10

Receiving the scholarship excludes the scholarship holder from receiving the following scholarships from their own scholarship funds: the Franciszek Mertens Scholarship Fund and the Jagiellonian University Scholarship.

§ 11

In exceptional cases, the Dean of the Faculty may change the deadlines provided in these Regulations.

§ 12

Administrative support for the scholarship from the Fund is provided by the Faculty of Mathematics and Computer Science of the Jagiellonian University.

§ 13

The Rector of the Jagiellonian University decides on the termination of the Fund's operations and the allocation of funds remaining on the Fund's account unless the agreement with the donor provides otherwise in the case of donations.

§ 14

Pursuant to Art. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as "GDPR"), the Jagiellonian University informs that:

- 1) the administrator of personal data of the participant of the competition for a scholarship under the Julia Zdanowska Scholarship Fund, hereinafter referred to as the "competition", is the Jagiellonian University, based at 24 Gołębia street, 31–007 Kraków, represented by the Rector of the Jagiellonian University;
- 2) The Jagiellonian University has appointed a Data Protection Inspector, based at 4 Czapskich street, 31–110 Kraków, room no. 25. The Inspector can be contacted by e-mail: iod@uj.edu.pl or by telephone at 12 663 12 25, from Monday to Friday, from 8:00 to 15:00;

- 3) personal data of the competition participant provided in the application to participate in the competition will be processed:
- a) in the case of all competition participants for the purpose of organizing and conducting the competition pursuant to Art. 6 section 1 f of the GDPR, i.e. in fulfilment of the legitimate interest of the administrator consisting in selecting the winner in the organized competition,
- b) in the case of a competition participant who is a scholarship holder or a person on the reserve list for a scholarship in order to fulfil the legal obligations imposed on the organizer as the person promising the prize, i.e. pursuant to Art. 6 section 1c of the GDPR.
- 4) providing personal data by the competition participant is necessary to participate in the competition. The consequence of not providing personal data will be the inability to participate in the competition. In the case of competition participants referred to in point 3 b, providing data is a legal obligation, and failure to provide them will prevent the competition participant from receiving award.
- 5) personal data of competition participants referred to in point 3a will not be made available to entities outside the organizer's staff.
- 6) personal data of competition participants referred to in point 3 b, regarding name and surname will be posted on the website of the Faculty of Mathematics and Computer Science of the Jagiellonian University. These data will also be made available to authorized state authorities, in particular to the extent that they are authorized to verify the fulfilment of legal obligations imposed on the organizer as the promisee of the award.
- 7) personal data of the competition participant will not be transferred to third countries (outside the European Economic Area) or to international organizations.
- 8) personal data of competition participants referred to in point 3 a, will be processed until the competition is resolved and information about its outcome is provided. Personal data of competition participants referred to in point 3 b, will be processed for the period provided for by tax regulations, and then for archival purposes in accordance with the applicable legal provisions.
- 9) the competition participant has the right to: obtain information about the processing of personal data and rights pursuant to the GDPR, access the content of his or her data and rectify it, as well as the right to delete personal data from the administrator's files (unless further processing is necessary to fulfil the legal obligation or in order to establish, pursue or defend claims) and the right to limit processing, transferring data as well as object to processing it in the cases and under the conditions specified in the GDPR;
- 10) personal data of the competition participant will not be subject to automatic decision-making or profiling.
- 11) the competition participant has the right to lodge a complaint with the President of the Personal Data Protection Office, if he considers that the processing of his personal data violates the provisions of the GDPR.

## Additional benefits available to a scholarship holder of the Julia Zdanowska Scholarship Fund:

- 1) the maximum qualification result in recruitment for first-cycle studies in the field of study specified in the decision of the Dean of the Faculty referred to in § 7 section 4 of the Regulations and for second-cycle studies in the event of extension of eligibility specified in § 4 section 4 of the Regulations; recruitment of scholarship holders is carried out under a separate path based on the schedule specified by the Rector of the Jagiellonian University.
- 2) a guarantee of being granted a place in a student dormitory, paid for from the scholarship holder's own funds, during the period for which the scholarship was granted, provided that the scholarship holder applies for this place in accordance with separate regulations.
- 3) possibility of participating in a Polish language course (the level of the course and the number of hours are determined by the Dean of the Faculty according to the needs of the scholarship holder);
- 4) not paying tuition fees for full-time first-cycle studies in fields of study conducted at the Faculty, and in the case referred to in § 4 section 4 of the Regulations, i.e. extension of the use of rights no fees for education during full-time second-cycle studies.
